Our output from the project to date consists of 5 published papers, 6 forthcoming papers, 4 Conference presentations, 2 reports and 2 other submitted papers. This makes **19 completed papers**. Several other papers are in progress. Many of these papers are available from the project's web-site at:

The research is organised into two specific areas. The first has a macroeconomic focus and links together the determinants of military expenditure and its consequences for economic growth. This research has been mainly empirical using individual country studies, relatively homogenous groups of countries and panel data. The second has a microeconomic focus and examines the interactions between procurement, the arms trade and the restructuring process in the defence sector. Many aspects of this work address what defence specialists call "The Revolution in Military Affairs" (RMA) or the ways that new technology are transforming fighting. A forthcoming Economic Policy article to be presented at an Economic Policy Panel in September 2003, will present an economic analysis of the RMA, and serve as an overview of the main output of the project at a prestigious event.
